

WHEREAS, the By-Laws of JUPITER COVE CONDOMINIUM ASSOCIATION, INC. ("Association") of 1450 Jupiter Cove Dr., Jupiter, Florida 33458, are attached as Exhibit "E" to the Declaration of Condominium of JUPITER COVE a Condominium, recorded in Official Record Book 3204 at Page 0665, Public Records of Palm Beach County, Florida, ("Declaration"); and

WHEREAS, ARTICLE 8 of the By-Laws provides for amendment of the By-Laws by the affirmative vote of not less than a majority of the Board of Administration and by a majority of the unit owners; and

whereas, the Board of Administration and the Unit Owners of the Association voted to amend the By-Laws and approved the amendment hereafter provided at a duly called meeting of the Unit Owners held on October 3, 2000.

NOW, THEREFORE, the following sections of the By-Laws of Jupiter Cove Condominium Association, Inc., are hereby amended as hereafter provided:

- 1. "9.6 No radio or television aerial installation shall be made on any condominium building. However satellite dishes may be installed on building roofs by the Association."
- 2. Except as specifically amended bereby, the By-Laws shall remain in full force and effect as recorded.
